If you have not nominated your preferred distribution method or have selected to pay your distribution into a bank account and have not provided us with your bank account details, this will be taken to be a direction to participate in the DRP plan.

**The Distribution Reinvestment Plan (DRP)** will operate for this distribution.

Investors who would like to participate in the DRP should ensure an election is made by 5PM Wednesday, 12 May 2021.
