Subject | Chi-X Australia rebranding to Cboe Australia from 1 February 2022

Dear Customers and Members of our Trading Community,

In June 2021, Cboe Global Markets, Inc. (Cboe), a leading provider of global market infrastructure and tradable products, completed its acquisition of Chi-X Asia-Pacific Holdings Ltd and its subsidiaries including Chi-X Australia Pty Ltd (collectively Chi-X).

Over the past 10 years, Chi-X Australia has established its reputation as an innovative stock exchange providing local and global investment opportunities to the Australian market with a focus on strong customer service. The acquisition enables Chi-X to continue to deliver these benefits to the Australian market including new trading solutions and services that Cboe offers, such as the industry-leading block trading capabilities of BIDS Trading.

As part of the integration with Cboe, Chi-X will be rebranding to Cboe from 1 February 2022. This will include a company name change from Chi-X Australia Pty Ltd to Cboe Australia Pty Ltd, and changes to the website, email addresses and logo.
